Categories and types of personal data processed

By visiting and / or using this site, various types of data will be collected which may be collected by the site independently or provided voluntarily by the user.

• Data provided voluntarily by the user

• **Profiling and other commercial treatments**

CHEMI-VIT SRL will process user data, subject to specific and explicit consent, for the analysis of preferences, habits, behaviors and interests derived, for example, from online clicks on articles / sections of the Site and / or the data that the user releases to use the individual services.

Profiling involves processing of the data that the user releases to create groups of consumers divided by market segments based on a combination of elements (e.g. gender, country of origin, age) up to more complex profiles based on preferences, online behavior and previous purchases. Processing

Place of processing
